Brief details of claim

- 1. On or around 25 July 2023, Nominet UK ("Nominet") purported to remove Claimant as a candidate in their 2023 Non-Executive Director election, in breach of contract, breach of duty and ultra vires to their corporate governance or otherwise.
- 2. Election uses disputed weighted voting that changed result of 2022 election.
- 3. Nominet provides an ADR service called the DRS for domain name disputes. In an ongoing DRS case about the ownership of the domain name QuickQuid.co.uk (in which the Claimant Mr Davies was a Complainant), Nominet (through its General Counsel) was obliged to determine issues as a neutral arbiter, while aware of this dispute. Despite that, Mr Wenban-Smith ignored the question of perceived bias and ruled against Mr Davies in the QuickQuid.co.uk DRS.
- 4. Claimant seeks to be declared the winner of the 2022 Nominet NED election; alternatively be reinstated in the Nominet 2023 NED Election and/or in the alternative damages; and further seeks a declaration that the procedure in the QuickQuid.co.uk DRS did not follow due process and an order that it should be re-run.
